In continuation to the revision in MBU Policy and introduction of provision for Home Enrolment Service, the rate of assistance to Registrars and fees applicable to residents issued vide OM No. HQ-16033/1/2020-EU-I-HQ-Part(2) (E-8026) dated 18.10.2022 stands revised as follows:

- If the service is availed by more than one resident at the same address (as per Aadhaar), Rs 700/- service charge (including GST) will be charged for first resident and @ Rs 350/- (including GST) for each additional resident.
- All the rates mentioned above are inclusive of GST and Registrars are requested to submit the Tax Invoice against the Assistance to be provided by UIDAI for processing the payment.
- For Registrars not functioning under in-house model as per OM No. 16024/4/2022-EU-I-HQ-Part(1) dated 30.01.2023, the applicable rate for assistance shall be as per Table 2 of Circular dated 09.05.2020.
