

PRESS RELEASE

It is to bring to the kind notice of all concerned that the Government of India, Department of Social Justice and Empowerment, Development and Welfare Board for De-notified and semi-Nomadic Communities is implementing a scheme namely, **Scheme for Economic Empowerment of DNTs (SEED) for the Development and Welfare of DNT/NT/SNTs**. One of the scheme components is to provide free coaching of good quality for DNT students to enable them to appear in competitive examination. For the competitive exams for which the qualifying exam is class 12th, benefits under the scheme will be available to a candidate only if the candidate has passed class 12th or is studying in class 12th as on the date of receiving the benefit under the scheme. Presently, the scheme is launched for providing financial assistance to avail free coaching for 4000 DNT students during the current financial year. As per the scheme norms, the students of DNT communities having total family income from all sources of ₹8.00 lakh or less per annum and not availing any such benefits from similar Scheme of Centre Government or the State Government will be eligible for benefits under the Scheme.

It is also requested by the GoI to issue DNT Caste Certificates to DNT community peoples in a time bound manner after verification or credentials and other requirements.

Therefore, all concerned School/College Principals of State/UT to support the identification of DNT students and facilitate the issuance of DNT certificates for availing free coaching benefits under scheme for Economic Empowerment of DNTs (SEED). The Scheme seeks to improve the socio-economic conditions of one of the most disadvantaged section of our population.
