- 1) The firm/agency must have prior experience in providing similar services for sports event, government functions or large public events.
- 2) The firm should not have been blacklisted by any Central/ State Government Department.
- 3) The firm must possess valid PAN Card and GST Registration.
- 4) Quotation shall be submitted in a sealed envelope superscribed: "Quotation for Ceremony/ Tent / Light & Sound Facilities -69th NSG U-19 Girls Handball Tournament".
- 5) List of enclosures to be submitted with the quotation -
 - i. Acceptance of all terms & conditions of the tender. (Annexure-A&B)
 - ii. Financial Bid (Annexure-C)
 - iii. Copy of PAN card of the firm.
 - iv. Copy of GST registration number.
 - v. Name of Firm, Address a/w Bank detail in which payment is to be made.
- 6) The quotation should reach the office of the undersigned on or **before 27/01/2026 up to 11 AM.**
- 7) The quotation shall be evaluated on the basis of lowest responsive rate (L-1), subject to fulfillment of all terms and satisfactory past performance.
- 8) The competent authority reserves the right to accept or reject any or all quotations without assigning any reason.
- 9) Rates quoted shall be inclusive of all taxes, duties, labour, transportation and incidental charges.
- 10) Payment shall be made after satisfactory completion of the event. No advance payment shall be admissible.
- 11) Any deficiency in services shall attract penalty as decided by the competent authority.
- 12) Subletting of work is not permitted without prior written approval.
- 13) The decision of the competent authority shall be final and binding.
- 14) The safety, security from student/participant perspective and uninterrupted services during the tournament shall be the sole responsibility of the firm.
- 15) The vendor shall deploy his technical team (sensitive persons) to ensure the required services in a smooth and efficient manner. They shall be bearing proper ID Card expressively displaying their name.
- 16) *Any untoward incident related to the services provided by the firm concerned shall be the sole responsibility of the awardee.*
- 17) In case of unsatisfactory services, the Principal/DDO, Govt. Boys Sr. Sec. School Ghumarwin Distt. Bilaspur HP reserves the right to impose penalty or cancel the award/contract (if any).
- 18) Subletting of work shall not be permitted without prior written approval.
- 19) Jurisdiction: All questions, disputes and/or differences arising under and out of, or in connection with the contact, if concluded, shall be referred to the Court at Ghumarwin District Bilaspur HP.
- 20) Penalty Clause :- In case of poor services, short supply, delay in service and similar other issues , a penalty shall be imposed depending upon the gravity of lapses and as per sole discretion of the procuring entity i.e. Principal/DDO, Govt. Boys Sr. Sec. School Ghumarwin Distt. Bilaspur HP.
