

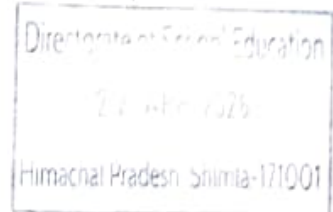

Subject: Regarding the delivery of digital devices under the "Srinivasa Ramanujan Students Digital Yojna".

Memo

In continuation of this office letter of even number dated 20.03.2026 and 04.04.2026, and with reference to the e-RUPI cards/redemption vouchers issued by Indian Bank for distribution to meritorious students, this is to bring to your attention that these vouchers have not yet been distributed to the eligible students by several schools. Consequently, students are facing difficulties in understanding the redemption process, and it has been noted that the contact numbers provided by school authorities are often incorrect, leading students to contact higher authorities for resolution.

Therefore, you are directed to ensure that all e-RUPI cards/vouchers are distributed to the beneficiaries immediately. These vouchers contain all necessary instructions regarding the redemption process. Furthermore, you must upload the required proforma on your website and disseminate it to all concerned schools. This process must be verified by the Head of the respective GSSS/GHS.

You are further directed to convey the following instructions to the Heads of all GSSSs/GHSs under your jurisdiction:

1. Meritorious students will receive an e-RUPI voucher amounting to ₹16,000/-, while two-year toppers (10th grade - 2023 & 12th grade - 2025) will receive ₹32,000/-. These will be sent by Indian Bank in the following format: "Dear User, an e-RUPI voucher #..... (Voucher code) for the Electronics shop scheme is created for a maximum value of INR 16,000.00, valid till dd/mm/yyyy. Please do not forward or share this voucher SMS QR with anyone other than the merchant at the merchant point." The voucher must be kept safe and presented to the dealer when the student collects the device. Upon successful redemption, the device will be handed over.
2. After receiving the e-RUPI card, the student must log in with their registered mobile number on the dashboard using the link provided in the voucher.
3. At the time of delivery, the student will select their preferred district for device collection. The vendor will deliver the device based on this selection.
4. Once the device is selected, the vendor will communicate the specific place and time of delivery to the student.

5. Please note that once the device is selected by the student, delivery may take 6-8 weeks.
6. Students opting for a device with a value exceeding the e-RUPI voucher amount will have to pay the difference directly to the vendor via digital payment modes (avoiding cash).

Furthermore, it is a matter of concern that, despite previous rectifications, the department is still receiving complaints regarding incorrect contact numbers. We have already updated the contact details for 313 students and processed a second list of 180 students; however, complaints persist.

Additionally, some students have reported that they did not receive the message regarding the e-RUPI cards, or that they mistakenly deleted it. You are required to personally collect accurate data from the beneficiaries regarding these issues—ensuring there is no repetition—and submit the finalized, rectified list to this directorate on or before 24.04.2026.

Please note that no queries will be entertained after this stipulated time. It is the sole responsibility of the Principal to ensure students are guided properly.
